

MOEA PRIVACY POLICY

MOEA and MOEA Band are part of Mister B Music Limited. This Privacy Policy will explain how our organisation uses the personal data we collect from you when you use our website.

WHAT DATA WE COLLECT?

Mister B Music Limited collects the following data:

- Personal identification information (name, address, email address, phone number, ...)
- Payment details

HOW DO WE COLLECT YOUR DATA?

You directly provide Mister B Music Limited with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products;
- Voluntarily complete a customer survey or provided feedback on any of our message boards or via email;
- Use or view our website via your browser's cookies.

HOW WILL WE USE YOUR DATA?

Mister B Music Limited collects your data so that we can:

- Process your order;
- Email you with new products and updates on the band's activity.

When Mister B Music Limited processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

HOW DO WE STORE YOUR DATA?

Mister B Music Limited securely stores your data at our registered premises address.

Mister B Music Limited will keep your personal and payment data until you tell us that you do not wish to be contacted anymore and would like us to take you off our system. When we receive your decision to be take off our system, we will delete all information attached to your name, including your name.

MARKETING

Mister B Music Limited would like to send you information about new releases that we think you might like.

If you have agreed to receive marketing, you may always opt out at a later date.

WHAT ARE YOUR DATA PROTECTION RIGHTS?

Mister B Music Limited would like to make sure you are fully aware of all your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Mister B Music Limited for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Mister B Music Limited correct any information you believe is inaccurate. You also have the right to request Mister B Music Limited to complete information you believe is incomplete.

The right to erasure – You have the right to request that Mister B Music Limited erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Mister B Music Limited restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Mister B Music Limited's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Mister B Music Limited transfer the data that we have collected to another organisation, or directly to you, under certain conditions.

WHAT ARE COOKIES?

Cookies are text files placed on your computer to collect standard Internet log information and visitor behaviour information. When you visit our website, we may collect information from you automatically through cookies or similar technology.
